2. ACH Orders: while the acknowledgement/invoice will show as \$0 due, please note that the billing will occur after the acknowledgement is sent and will include the full amount payable.
3. Orders shipped outside the U.S.: duties, taxes and other applicable charges are the responsibility of the consignee.
4. Return policy: All products must be returned in saleable condition. Returns must be received by A4A within 30 days of the invoice date, postage and freight charges must be pre-paid by the purchaser, A4A cannot credit accounts for any reason after 30 days of the invoice date, CD-ROMs must not be opened, all requests for refunds must be made in writing and credits must be used within one year of the date of the credit memo. There will be no refund or credit issued on any PDF files.
