In reply to a question of the Chamber, the applicants' representative confirmed their written answers of 14 September 2020 to the questions of 11 August 2020 posed by the Court, by which they clarified their heads of claim, to the effect that they thereby pursue a single head of claim, namely the annulment of the decision of the European Commission of 22 January 2019 in case C(2019) 639 final.
