Hi Stuart,

Thanks for your time this morning/afternoon to discuss the European Court of Justice decision in the Public.Resources.Org case, its implications and next steps.

As we mentioned, CEN-CENELEC and the National Standards Bodies have been requested by the European Commission to investigate mechanisms to provide access to harmonised European standards (hENs). One of the options under consideration by CEN-CENELEC and NSBs is deployment of decentralised standards portals by NSBs individually.

The features of such NSB decentralised standards portals would be:

- 1. Read only access to harmonised European Standards
- 2. No copying, no printing or downloading of the publications
- 3. End-users must register and accept the terms of use of the portal
- 4. Portal would include visible information for the end-user that the publications are protected by copyright and licensed.

With regard to timelines on this, the Commission advised CEN-CENELEC of the following:

#### 1. Four harmonised European Standards which were the subject of the Public.Resources.Org case

The Commission have indicated that CEN-CENELEC / NSBs are required to implement a mechanism to make the four standards (which were the subject of the court case) by mid April 2024.

The four standards are-

EN 71-5:2015, 'Safety of toys – Part 5: Chemical toys (sets) other than experimental sets', EN 71-4:2013, 'Safety of toys – Part 4: Experimental sets for chemistry and related activities', EN 71-12:2013, 'Safety of toys – Part 12: N-Nitrosamines and N-nitrosatable substances' EN 12472:2005+A 1:2009, 'Method for the simulation of wear and corrosion for the detection of nickel released from coated items'.

# 2. All other harmonised European Standards

The Commission indicated that new platform / decentralised portals for access to hENs would need to be in place by  $1^{st}$  September 2024. However, a few NSBs have indicated that they would be in a position to operationalise a portal within about 6 weeks (ca late April / early May).

As we discussed earlier, in terms of compensation for providing "free" access of hENs to end users, we have no information from the Commission yet on this. In addition, we have no information on whether the Commission will funding the cost of developing and implementing such portals by NSBs / CEN-CENELEC.

Based on the above information, we would be grateful if Intertek Inform would prepare a proposal for developing and rolling-out a decentralised read-only portal for I.S. ENs which are harmonised standards. We'd be grateful if the proposal would consider the functionality of a read-only portal, timelines for implementing such a portal and costs associated with developing such a portal.
