- All documents dated from 2016 to the present relating to: (i) the copyright status of state codes and related materials, including headings and annotations, or other edicts of government, such as jury instructions; (ii) potential copyright infringement actions, including the relevant parties and bases for the action, concerning state codes and related materials, including headings and annotations, or other edicts of government, such as jury instructions; (iii) patent claims regarding state codes and related materials, including headings and annotations, or other edicts of government, such as jury instructions; (iii) patent claims regarding state codes and related materials, including headings and annotations, or other edicts of government, such as jury instructions; (iv) access

to state codes and related materials by the public, libraries, legal information services providers, legal bar associations, or any other person or organization; and (v) any complaints, including by third parties, regarding inability to access any of the materials described above.
