Dear Mr. Malamud:

This responds to your Freedom of Information Act (FOIA) request to the U.S. Department of Homeland Security (DHS) Privacy Office (PRIV), dated May 20, 2009. PRIV referred your request to the Office of Inspector General (OIG), which OIG received on June 10, 2009 and assigned the above-referenced tracking number. Your request seeks records that would assist you in determining the amount of money the Department spends on access to federal court documents and other primary legal materials, to include the following:

- 1. Any memoranda or budgetary documents that detail the total amount spent by the Department of Homeland Security (DHS) to access PACER from 2000 to present, as well as budget items for future fiscal periods.
- 2. Any agreements, contracts, or memoranda of understanding governing access to PACER by DHS staff.
- 3. Any memoranda or documents from DHS asking DHS lawyers to limit their use of PACER due to cost considerations.
- 4. Any contracts, memoranda, or budgetary materials detailing agreements and amount of money spent by DHS with commercial legal information providers such as Thomson Westlaw or the ReedElsiveir LexisNexis service.

The OIG conducts independent investigations, audits, inspections, and special reviews of DHS personnel, programs, and operations to detect and deter waste, fraud, and abuse, and to promote integrity, economy, and efficiency within the Department.

As it pertains to item #1 of your request seeking total amount spent by OIG to access the PACER system, please note that OIG gained access to PACER in October of 2006; therefore, attached are the redacted copies of the PACER bills from October 1, 2006 through June 30, 2009.

As it pertains to the portion of item #1 seeking budgetary documents and budget for future fiscal periods, OIG has no records. Additionally, OIG has no records pertaining to items #2 and 3 of your request.

Finally, regarding item #4 of your request, please be advised that if any responsive documents exist, they would likely be under the purview of the DHS Directorate for Management. Therefore, we are transferring your request to that component for review and direct response to you. 




