This is the electronic final response to your May 28, 2009, Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS) for records relating the amount spent on access to federal court documents and other primary legal materials. This office received your request on July 21, 2009.

In responding to this FOIA request, the DHS/Management Directorate searched for responsive documents in its control on the date the search began. We began our search on July 23, 2009.

We are granting your request under the FOIA, Title 5 U.S.C. § 552, as amended, and DHS' implementing regulations, 6 C.F.R. Chapter I and Part 5. After carefully reviewing the responsive documents found within DHS Headquarters, I determined that they are appropriate for public release. They are enclosed in their entirety; no deletions or exemptions have been claimed.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. In this instance, because the cost is below the \$14 minimum, there is no charge.
