It is believed that this is the only Circuit where there are two Circuit Court Judges with co-ordinate jurisdiction. Judge WALLACE, the other Circuit Judge of this Circuit, is by a provision of the same law known as the Senior Circuit Judge of the Second Circuit, and Judge LACOMBE as the Junior Circuit Judge.
