(E) After the regulatory action [which includes notices of proposed rulemaking] has been published in the Federal Register or otherwise issued to the public, the agency shall:
(i) Make available to the public the information set forth in subsections (a)(3)(B) and (C);
(ii) Identify for the public, in a complete, clear, and simple manner, the substantive changes between the draft submitted to OIRA for review and the action subsequently announced; and
(iii) Identify for the public those changes in the regulatory action that were made at the suggestion or recommendation of OIRA.

In other words, the "agency" (NARA/OFR) is responsible for making available to the public information indicating the changes between the draft submitted to OIRA for review and the final proposed rulemaking published in the Federal Register, and identifying the changes made at the suggestion or recommendation of OIRA. That's what I'd like to see.
