SUMMARY OF MEETING: Subcommittee discussed the CPSC incidents involving carriers placed on soft, pillowy surfaces. Only 2 of the 6 incidents were after the new standard was published, but it is unknown whether those 2 were with old products. The committee asked the CPSC to consider requiring 'date of manufacture' being asked for when an incident is reported. Committee discussed a single incident involving the use of a carrier as a bath seat. Discussed issue of soft-sided products and changed the standard definition to say "rigid-sided" to exclude the 'Moses-basket' types of carriers. CPSC was asked to provide any incidents involving 'Moses-basket' type carriers.
