Sally,

I'm sorry for my delayed reply--I was out of the office until this morning because I was out of town to attend a funeral. At the end of last week, I did have an opportunity to discuss this with our Chairman and General Counsel. Although I'm very grateful you thought of me, I won't be able to participate in your case. As I suspected, there are some fairly stringent restrictions on federal employees serving as expert witnesses. Among other things, we would have to secure DOJ's authorization, which would require convincing their ethics officials that my service as an expert witness is in the Government's interests. Beyond that, we believe the most prudent policy is for ACUS employees not to take sides in private litigation. To do so would be in some measure inconsistent with the agency's neutral and consensus-based mission. Our members have a wide diversity of opinions, too, and only recommendations adopted by the Assembly can be understood to be the "views" of the Conference. It would likely be impossible to hew strictly to those views in any kind of expert testimony. And to venture too far beyond our recommendations would be to invite criticism and disapproval from our

members.

Thank you again for reaching me out to about this. It was a pleasure to speak with you last week, and I hope to do so again in the future. And I will continue to follow the litigation with interest.
