On behalf of the American National Standards Institute (ANSI), I am writing to invite you to moderate a roundtable discussion during ANSI's Legal Issues Forum, which will be part of [World Standards Week 2012](#) in Washington, DC.

The event will be held from 9 a.m. to 1 p.m. on Wednesday, October 10 and is entitled, "Incorporation by Reference, Reasonable Availability, and Copyright."
