Hope all goes well. The ANSI Caucus with Vanessa Sutherland from PHMSA went very well. Good discussion of the issues of incorporation by reference and the need for collaborative efforts to address the need for public access.

I would like to request a favor. We need a room on the Hill for April 11th to hold a high-level meeting on standards for congressional staff to discuss issues such as IBR, as well as global supply chain oversight (such as food and toy safety), cybersecurity, smart grid, etc. [A draft flyer for the event is attached]

ANSI, ACUS [the Administrative Conference of the United States], and NIST have been discussions for some time now about the idea of a joint event on the Hill to engage congressional staff on the benefits of the US public-private standardization system and how the consensus process can be helpful in developing solutions to public policy issues before Congress.
