>>>> The Administrative Conference of the U.S. ([acus.gov](http://www.acus.gov)) is a formal federal agency charged with making administrative law recommendations. I'm one of the public members, joining the general counsels of most large federal agencies.

>>>> They are doing a study on Standards Incorporated by Reference. The researcher for ACUS, Emily Schleicher, has spoken to groups such as ANSI and NFPA. As you know, the federal and state government adopt technical standards by reference, and those become binding on people. Examples range from building and fire codes to technical standards in telecom and materials (e.g., "definition of excessive levels of lead in paint used in schools").

>>>> Could you or one of your policy folks take a call with Emily? I wanted to make sure she spoke to standards bodies that don't charge for access to their standards. She's spoken with OASIS, but even a few minutes with you would be helpful. She'll be issuing a report, which will become a formal recommendation, probably this fall. The issue has visibility in the Congress as well. Your voice on open standards would be helpful.
