- 1. See the attached typical 2001 Agreement For Wording Changes.
- 2. Review each of the amendments in the loose leaf binder for the 2001 Publication Agreements and incorporate them into the 2004 agreements.
- 3. Check and revise the specific provisions for Parts 1, 6, 7, 8 &12 as they are different due to the copyright and web posting issues:
- 4. Change Paragraph 1.5 to 1.6 and insert a new Paragraph 1.5: (Publisher) further grants to the CBSC a license to post all errata and supplements which may contain material copyrighted by (Publisher) on the CBSC web site when they are published.
- 5. For Parts 1, 6, 7, 8 &12, remove "exclusive" from Paragraph 1.5 (now 1.6) as Paragraph 5 calls for posting these Parts on the website
- 6. In the Publication Agreement, add a anew Paragraph 3.4: "(Publisher) shall deliver to the CBSC 10 additional copies of all Errata and Supplements in addition to that specified in Paragraph 3.3 above.
- 7. In the Publication Agreement, add a new Paragraph 3.5: "(Publisher) shall deliver to CBSC an Adobe Acrobat .pdf file of all errata and supplements immediately following the publication of same for the purpose of posting them on the CBSC web site.
- 8. In A-6 of Attachment A Include a provision that all drafts/proofs shall be transmitted to and from CBSC by overnight service and that the publisher shall give CBSC their UPS or Fed-x account number so the publisher pays for all shipping.
- Publishers should provide a 'link address' to their website for availability of the codes which CBSC can use on its website so we do not have to maintain the listing of their resellers.
- 10. On Exhibit C, Page 4, the 19<sup>th</sup> item, note that the physical delivery address for the UC Irvine Library Government Information Department is: Science Library Receiving Dock, Building 520. Irvine, CA 92697. Be sure to include the mailing address for supplements, errata, etc.
- On Exhibit D, for the department of Corrections, send the codes to: Planning and Construction, Department of Corrections, 501 J Street - Rm 301, Sacramento, CA 95814 (Horace Adams)
- 12. On Exhibit D, Add Sending one set to Board of Corrections, 600 Bercut Drive. Sacramento, CA 95814
- 13. On Exhibit D, Send two copies to the Department of Corrections, Facilities Management Division, Day Labor and Professional Services, 501 J Street – Rm. 301, Sacramento, CA 95814

- 14. In the last bullet of Paragraph A.7.3 of Attachment A, it should be re-written to read: The page numbers of the supplements and/or errata where new, additional pages are inserted shall be the number of the last originally published page followed by .1, .2, .3 etc.
- 15. In the second last bullet of the Attachment A, General Terms A.8, for the Subscription cards, add the requirement that they be wrapped inside the shrink wrapped Code. When they are loose, they get lost.
- 16. Immediately above the second last bullet of the Attachment A, General Terms A.8, add a new bullet: To insure the complete document is delivered, each copy of the Code shall be shrink wrapped.
