Dear Katrina,

Thank you for the revisions which you made to the NFPA/CBSC agreement regarding the production of the 2016 California Electrical Code, which is largely referred to as the Code. Debra and I have gone through your version closely and as you might anticipate in a contract of this importance, we do have a couple of final comments and suggestions. Let me set them out herein in numerical fashion:

1. Exhibit A page 3 Section B, we note two instances of the Code being spelled with a small c. We have gone through the document and believe this is the only place where that small c was used. Unless there is some reason, this should probably be a capital C. **CBSC will change**
2. Exhibit A page 5 Section G, the reference to 35 days should be 45 days. **Okay to leave as 35.**
3. Exhibit A page 3 section 4 A 3, you should understand that NFPA copyright requirements will include the NFPA logo and the NEC logo on the cover.

In order to cover this we suggest that the above referenced section be revised to include reference to trademark requirements with the following language.

3. Affix copyright **and trademark** notices to the Code as directed by CBSC and required by NFPA **CBSC will add and trademark.**

In this regard we note that Section 6 I 4.1 (Ex. A p. 6 of 7) references material that is supposed to be delivered to NFPA by April 1, including the cover art along with other material. Were these materials delivered to BNI? IF not a different date needs to be included as we have not seen any of these items. In the previous iteration of this contract these materials were not simply referenced but were actually included in Exhibits that NFPA had a right to review prior to the printing. Because of the importance of properly acknowledging the NFPA and including the NFPA logo and the NEC logo, we will want assurance that these items will be properly displayed.

In the previous contract the following statement was include that seems to have been dropped this time:

12. Title page and binder cover of all publications of the code shall bear the trademark of NFPA in a form approved by NFPA. **We believe with adding 'and trademark' to the above language this will be all inclusive and won't necessitate adding this language again – but Debra will need to speak with Dennis.**

Thank you again and I hope with these comments addressed this should be finalized.
