Dear Mr. Stoltz:

This letter is the first interim response to your clarified April 9, 2014, Freedom of Information Act (FOIA) request (#2014-000658) to the National Institute of Standards and Technology (NIST) in which you requested "the following records:

- 1. All records (including, but not limited to, electronic records) of correspondence and/or meetings between any personnel of the NIST Engineering Laboratory and any employee, officer, agent, or representative of any of the following organizations between April 13, 2007 and the present:
 - a. American National Standard Institute (ANSI);
 - b. National Fire Protection Association (NFPA);
 - c. American Society of Hearing, Refrigerating and Air-Conditioning Engineers (ASHRAE); or
 - d. American Society for Testing and Materials (ASTM or ASTM International).

on the subject of the adoption of standards created by the above organizations as binding law by U.S. states or the federal government, including incorporation by reference.

- 2. All records (including, but not limited to, electronic records) of correspondence and/or meetings between any personnel of the Building and Fire Research Laboratory and any employee, officer, agent, or representative of NFPA between April 13, 2007 and the present, on the subject of adoption of NFPA standards as binding law by U.S. states or the federal government, including incorporation by reference.
- 3. All records (including, but not limited to, electronic records) of correspondence and/or meetings between NIST official Mary Saunders and any employee, officer, agent, or representative of any of the organizations listed in request number 1 between April 13, 2007 and the present, on the subject of adoption of standards created by those organizations as binding law by U.S. states or the federal government, including incorporation by reference.



NIST continues to conduct a search of our files responsive to your FOIA request. Enclosed you will find two (2) responsive documents consisting of two (2) pages that are being released in their entirety. NIST will continue to search for additional documents related to your request and send you releasable documents on a rolling basis as they become available.

The FOIA permits an agency to extend the time limits up to 10 days in unusual circumstances. These circumstances include the need to collect records from remote locations, review large numbers of records, and consult with other agencies. To process your request we will need additional time for the search, review and duplication of responsive documents; therefore, I am invoking an automatic ten-working-day extension to respond to your pending FOIA request. Responsive documents will be forwarded to you on a rolling basis as they become available.

PIPELINES: House bill offers 2-year extension for PHMSA on safety transparency rule (Monday, July 1, 2013)

A bill floated by the bipartisan leadership of the House Transportation and Infrastructure Committee would give oil and gas pipeline safety regulators two extra years to comply with a law that mandates the public availability of industry standards they use in rulemakings.

At issue is language in Congress' 2011 pipeline safety reauthorization that gave the Pipeline and Hazardous Materials Safety Administration (PHMSA) one year to carve out room for free public access to engineering safety standards that are commonly used in government rulemakings without their full text appearing in the regulation, a practice known as "incorporation by reference" (Greenwire, July 13, 2012).

Legislation introduced Friday by Chairman Bill Shuster (R-Pa.) and the committee's ranking Democrat, Rep. Corrine Brown of Florida, would extend by two years the deadline for PHMSA to only incorporate publicly available industry standards. The measure would also strike language requiring that the standards be posted online and limit the transparency requirement to standards used in rules, as opposed to nonbinding agency guidance.

While pipeline safety advocates have pressed for more public access to often-complex engineering standards for oil and gas transportation, industry groups and engineering trade associations have warned that such openness risks infringing on the intellectual property rights of the standards' authors.
