CO alarms are a bit of a big deal and, of course, a bit controversial. One angle to that story would be that a requirement for alarms was recently included in the I-codes but only for some homes (Steve Ferguson should be able to help with details on that). Our committee believes they should be in all homes as the threat of CO poisoning can come from a wide variety of sources – not entirely predictable. Other than that, some are just clean up or implementing recent interpretations. A storyline might be that as the standard is becoming more widely used (some code adoptions and green building programs), issues come up requiring clarification in the language. Addenda m and s are more substantial changes. S would give different credit for different types of ventilation systems – first time we've proposed that.
