MEMORANDUM OF POINTS & AUTHORITIES

It is proper for J. Kevin Fee to appear in this action as counsel *pro hac* vice pursuant to Rule 9.40(a) of the California Rules of Court, which state, in part, that:

A person who is not a member of the State Bar of California but who is a member in good standing of and eligible to practice before the bar of any United States court or of the highest court in any state, territory or insular possession of the United States, and who has been retained to appear on a particular cause pending in a court of this state, may in the discretion of such court be permitted upon written application to appear as counsel pro hac vice, provided that an active member of the State Bar of California is associated as attorney of record.

A party's right to appear by counsel of its own choice, including counsel appearing pro hac vice, is a right of paramount importance. Cornish v. Superior Court (1990) 209 Cal. App. 3d 467, 478. "That right should not be abrogated absent some indication that the adverse party will be unfairly disadvantaged." Id. Only "extreme circumstances" can possibly justify denial of a pro hac vice application. Magee v. Superior Court (1973) 8 Cal. 3d 949, 953.

It is appropriate that this application be heard and granted, as Proposed Intervenor International Code Council, Inc. expect that Mr. Fee's participation and appearance may be required on their behalf from time to time throughout the course of this action. Proper and timely notice of this application has been given to all parties that have appeared in this cause and upon the State Bar of California at its San Francisco office.
